November 11th, 2018 - A group of local butchers file a civil lawsuit against the state claiming the law violated their rights under the Privileges and Immunities Clause of the Fourteenth Amendment These historic "Slaughterhouse Cases" made their way to the U S Supreme Court which ruled on the matter in 1873 agreeing with the state
